The Center for Women & Children

Ridgeview's Center for Women & Children is making progress and will open in spring 2009. Plans have been finalized and construction is scheduled to begin this fall. When completed, Ridgeview's new Center for Women & Children will be the most comprehensive health care resource of its kind in the west-metro area and will offer services to women at all stages of their lives.

The new Birthing Center, located on the third floor of the hospital, will include six birthing rooms; 18 private, postpartum rooms with hotel-like décor and amenities; two rooms dedicated to C-sections; two antepartum rooms; and a nursery. A soothing color scheme and elegant design features will provide a relaxing environment for patients and their family members. Facilities will be in place for new mothers to have the option to labor and deliver in water.

A new level III Neonatal Intensive Care Unit (NICU) will be on the hospital's second floor, and will be the only level III NICU in the Twin Cities west of I-494. The NICU and our partnership with Children's Hospital and Clinics of Minnesota will enable

Ridgeview to provide long-term care for babies with special needs, allowing them stay closer to home.

In addition, a major update will be made to the existing Pediatrics Unit, and the Women's Imaging & Breast Center will also see a \$1.5 million enhancement in its diagnostic technology.

Ridgeview is committed to providing women and children in our community with a comprehensive network of quality, compassionate care that is close to home and maximizes their well-being.

Chaska Hospice Residence Update

Groundbreaking for Ridgeview's new residential hospice facility will be held this summer. The residence will be located in Chaska, on a beautiful 3-acre site gifted by the City of Chaska on the southwest side of Lake Bavaria.

Hospice is a special kind of holistic care provided to people in the final stages of life. The new hospice residence is the first of its kind in the west-metro area and will provide patients an additional end-of-life care option. This is especially important to families that cannot care for their loved ones in the comfort of their home.

During hospice care, patients will at times require a short-term stay in a hospital to better manage their symptoms. The hospice residence will offer comfortable

surroundings when this type of inpatient care is necessary. Additionally, it can be a place where a hospice patient can receive care when family members need a planned break.

The facility will be Medicare certified, with 24-hour care focused on the patient and his or her family. The home-like private rooms will allow family and friends to gather together to support their loved ones during this precious time. Guest rooms will be available to family members for overnight stays, as well as a large kitchen, private gathering areas and scenic areas surrounding Lake Bavaria.

The hospice residence will be 100 percent funded by philanthropy, including a generous lead gift from Paul and Sheila Steiner of Waconia.

Heart Center Update

The Minneapolis Heart Institute® at Ridgeview Heart Center opened its doors in October 2007 and brought a new level of cardiovascular care to the west-metro area. The Heart Center allows patients to receive advanced cardiac care while remaining close to their families and primary physicians.

Since its inception, the Heart Center has experienced significant growth in both services and staff. "I didn't expect us to grow quite this fast," explains Ben Nielsen, director of Cardiovascular Services. "Our advanced technology—combined with the leadership of our medical director, Dr. Luis Pagan-Carlo, and the efforts of the entire Heart Center staff—has enhanced the cardiovascular services offered locally and improved patient access to cardiovascular care."

Besides Dr. Pagan-Carlo, additional cardiovascular specialists from the Minneapolis Heart Institute include Dr. Scott Sharkey, Dr. Daniel Lips, Dr. Yale Wang and Ty Harrison, physician assistant.

Service expansion to date:

- Opening of the catheterization lab for coronary diagnostic procedures
- Diagnostic testing for vascular disease (interventional radiology procedures)
- Vascular clinic
- 24/7 echocardiogram coverage
- Pacemaker checks
- Protocol to ease allergic response to the antiplatelet drug Plavix (Plavix desensitization)
- Chest pain protocols in the emergency room

Future expansion:

- Wound care services
- Heart rhythm diagnostics and treatment (electrophysiology clinic)
- Nonsurgical interventional procedures



Ridgeview Medical Center Planning for New Medical Facility in Chaska

Facility to include stand-alone emergency room, and primary and specialty outpatient services

Ridgeview Medical Center is planning to open a three-story, 100,000-square-foot medical facility in Chaska. If more space is needed to meet the future needs of the community, the building can be expanded up to 200,000 square feet and six floors.

"This project complements Ridgeview's mission to offer new and needed services to the communities we serve. Research and the community's health care usage patterns indicate that a 24-hour emergency room and additional outpatient services may fulfill an unmet need in this area," says Robert Stevens, president and CEO of Ridgeview.

A free-standing ER—essentially a hospital without beds—will fulfill the need for convenient medical care and specialty services with easy access off of the new Highway 212. Along with the ER, other on-site primary and specialty outpatient services may include imaging (MRI, CT and ultrasound), surgery, clinics and more.

The facility will be located on the east side of Highway 41, between the new Highway 212 and Hundertmark Road in Chaska.
