A TRADITION OF CARE


In 2003, Ridgeview Medical Center celebrated its 40th anniversary of providing quality care to the people of Waconia and the surrounding communities.

- The Ridgeview Clinics opened three new clinic buildings. Those buildings are located in Howard Lake, Delano and Chanhassen.
- With the help of State Representative Paul Kohls and Senators Julianne Ortmann and Gen Olson, Ridgeview Medical Center received legislative authority to expand its licensed bed capacity from 109 beds to 129 beds.
- During 2003, 1,220 babies took their first breath of life at Ridgeview Medical Center. This is a record number of births for Ridgeview.
- Ridgeview Medical Center received the Governor's Award for Excellence in Waste and Pollution Prevention for its environmental and sustainability practices. In the history of the award, this is the first time a hospital has ever been awarded this recognition by the governor of Minnesota.

• Lastly, Ridgeview continues to be financially strong in order to carry out its mission and its goal of remaining an independent, nonprofit hospital system dedicated to improving the health of the communities we serve.

Bill and Pat Herrmann both wanted to give something back to the community, so they donate a few hours each week to Ridgeview. The long-time volunteers—nearly 13 years for Pat and 11 years for Bill—are quick to share their experiences, and time.

"For many people, volunteering fills a need in their lives. I felt it was time to give back to the community," said Pat, who responded to an ad in a local paper in 1991 looking for volunteers. "Everyone who is aware of Ridgeview realizes the great quality of life it provides for the community. We're very fortunate to have it here."

KIM GITTER

Kim Gitter, radiologic technologist in Ridgeview's Imaging Services Department, started working at the hospital while doing her clinical instruction training as a student at Argosy University, in Eagan. She liked the facility, its location and the experience at Ridgeview so much that when she graduated she applied for a job here and was hired. "I checked out other hospitals, but I really liked Ridgeview," she said. "I enjoy working here, and I am impressed with the hospital and the staff."



A \$4 million expansion was completed, including adding an additional patient floor; expanded emergency, surgery, special care and dietary departments; as well as new physical therapy, radiology, pharmacy and administrative quarters. The hospital's capacity is 109 beds and 20 bassinets.

Ground was broken for an \$11 million expansion that included a new emergency care facility and ambulance garages. It also allowed for expansion in the surgery areas, maternal/child health, lab, radiology, medical records, communication center and a gift shop. With additional support from Ridgeview Foundation, a large auditorium was added to the Waconia campus. The name of the facility was changed to Ridgeview Medical Center.

An underground tunnel connects the building to the hospital to allow for transportation of patients between the two buildings.




SIGNIFICANT CONTRIBUTION TO QUALITY OF CARE

Through generous gifts from friends and benefactors, Ridgeview Foundation transferred \$871,799 to Ridgeview Medical Center in 2003. These funds have made a significant difference in the quality of care at Ridgeview.

One hundred percent of every dollar gifted to Ridgeview Foundation is transferred to the Medical Center.

Through financial support from the community, Ridgeview completed its expansion of Surgical Services, built the Ridgeview Steiner Sleep Disorders Center, created a third hospice room and continued to transfer pledge payments of the \$1 million in commitments that were secured in 2002 for the newly created Cardiac-Intensive Care Unit.

This year Ridgeview completed a multi-million dollar building project adding a 60,000-square-foot facility housing an on-site MRI and an expanded Imaging Services Department, a state-of-the-art Cardiac-Intensive Care Unit and Women's Imaging & Breast Center.

COMMUNITY Benefits and Volunteers

While providing the highest-quality medical care is Ridgeview's top priority, the organization also has a vested interest in improving the health of the communities it serves.

Ridgeview Medical Center is one of the largest employers in Carver County. More than 1,200 personnel are now employed who, in turn, support area businesses, industry, churches and government.

Besides providing medical care to patients who cannot afford it, Ridgeview contributes hundreds of thousands of dollars in services, cash and in-kind donations and other programs to residents in its service area. Some of these contributions are highlighted below:

COMMUNITY EDUCATION/ OUTREACH

Ridgeview provides free and subsidized educational opportunities for the public. Many of these revolve around prenatal education and classes involving children. The organization is also present at more than a dozen community health fairs and business expos, providing blood pressure checks and offering information on Ridgeview services.

SCREENINGS

Each year Ridgeview holds free skin cancer and prostate cancer screenings for the public. Free and low-cost mammograms are also offered.

HEALTH INFORMATION Resource Center

Ridgeview Medical Center believes in informed decision-making, an important part of health care that not only encourages individuals to take an active role in decisions concerning them, but also to adopt healthy lifestyle behaviors. Our Health Information Resource Center has print and electronic resources on health topics written for the consumer. These items are available to use in the Resource Center or may be checked out. Patients, families and individuals in Ridgeview's service area may request a free literature search for information on a specific health topic.

VOLUNTEER SERVICES

As a nonprofit, independent hospital, Ridgeview relies on volunteers to contribute to the running of the organization. In 2003, about 300 volunteers donated a total of 26,064 hours to Ridgeview Medical Center and its clinics. Multiplied by the average hourly earnings figure determined by the U.S. Bureau of Labor Statistics, this works out to be a contribution of more than \$430,000.
